These programs are designed to be completed in EMT: 15 weeks, AEMT: another 12 weeks, Paramedic: another 28 weeks – EMT: 1 semester, AEMT: EMT + 1 semester, Paramedic: AEMT + 2 semesters.

These programs will cost \$1,699 for EMT, + \$3,659 for AEMT, + \$6,162 for Paramedic if completed within normal time. There may be additional costs for living expenses. These costs were accurate at the time of posting, but may have changed.

Of the students who completed these programs within normal time, the typical graduate leaves with \$ n/a of debt. *Fewer than 10 students completed these programs within normal time.
