Federal Direct Student Loans Instructions

Step 1: You must complete the VC Financial Aid process to be considered for a Federal Direct Subsidized or Unsubsidized Stafford Loan. This includes, but is not limited to, the Free Application for Federal Student Aid (FAFSA) and the VC Federal Direct Student Loan Request Form.

Step 2: You must complete the Master Promissory Note on Studentloans.gov. You will log onto Studentloans.gov using your FSA ID and password; if you don't already have an FSA ID and password created, click on Create an FSA ID link, and after completing this step you will use this FSA ID and password to log in. Once logged in, you will select the Complete a Master Promissory Note located in the middle of the screen, or on the right side select the option to "Complete MPN".

Step 3: In addition to signing your Master Promissory Note (MPN), you must complete the mandatory face-to-face Entrance Counseling Session. Details are available on the VC website at <u>www.victoriacollege.edu/loans</u>. **NOTE**: Victoria College requires all student borrowers to complete face-to-face Entrance Counseling at least once.

Step 4: Once your loan is processed it will be on your Pirate Portal in offer status and you must accept the award.

After your Financial Aid file is complete and your loan application has been processed, an award notification will be sent to your Pirate Portal email listing your eligibility based on your expected enrollment status. The initial award may be based on full-time enrollment (12 or more hours) with **revisions** made after the 12th class day (4th class day for summer sessions) for actual hours of enrollment and other aid received *which may cause a reduction in the actual amount received*. **NOTE:** If you fail to complete MPN or attend Entrance Counseling this will result in award not being posted to your account to pay tuition, fees, bookstore charges or receiving a refund.
