A tax rate of \$0.1709 per \$100 valuation has been proposed by the governing body of VICTORIA COUNTY JUNIOR COLLEGE DISTRICT.

The no-new-revenue tax rate is the tax rate for the 2024 tax year that will raise the same amount of property tax revenue for VICTORIA COUNTY JUNIOR COLLEGE DISTRICT from the same properties in both the 2023 tax year and the 2024 tax year.

The voter-approval rate is the highest tax rate that VICTORIA COUNTY JUNIOR COLLEGE DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that VICTORIA COUNTY JUNIOR COLLEGE DISTRICT is proposing to increase property taxes for the 2024 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 12, 2024 AT 4:00 PM AT 2200 E RED RIVER VICTORIA TX -ROOM 101 OF THE ACADEMIC BUILDING.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, VICTORIA COUNTY JUNIOR COLLEGE DISTRICT is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the THE PRESIDENT'S OFFICE of VICTORIA COUNTY JUNIOR COLLEGE DISTRICT at their offices or by attending the public hearing mentioned above.
