

## Statement of Financial Support

The United States Citizenship and Immigration Services (USCIS) requires international students to submit proof of financial solvency for an I-20 to be issued. **The estimated amount required for tuition, fees, and living expenses is \$18,182 U.S. dollars per year. Additional proof of \$2900 is required if you have dependents.**

Complete section 1, 2, and 3 with your information, any dependent information, and signature. Indicate the source of the funds in section 4. If a sponsor of family member is sponsoring you, have the individual who is supporting you *sign* and complete section 6 of this form and submit it with their bank statement.

If you are funded by multiple sponsors, each sponsor needs to provide this form along with a bank statement.

Two original sets of supporting documents should be obtained. Attach one set to this application. Keep the other set to apply for an F-1 visa at the U.S. Embassy or Consulate.

**In addition to this completed form, the student applicant and/or parent(s) or sponsor(s) must submit a current bank statement or have a bank official complete section 5 of this form. Additional guidelines attached.**
